Methodology

The methodology for the Corporate Citizens in Government Contracting list is the same as that of the 100 Best Corporate Citizens list with one additional data slice. The Best Corporate Citizens database comprises publicly-available data from Russell 1000 companies collected and analyzed by IW Financial, a Portland, Maine-based financial analysis firm serving the ESG (Environment, Social, Governance) investment community. The Corporate Citizens in Government Contracting list further refines that universe by identifying the overlap between the top 100 government contractors for FY2010 (according to USASpending.gov as of April 2011) and the Russell 1000. That universe of contractors (totaling 48 contractors this year) is then ranked according to the same methodology as we use for the 100 Best Corporate Citizens

The methodology collects 324 data elements in seven categories: climate change, employee relations, environment, financial, governance, human rights, philanthropy. The methodology weights the seven data categories differently to account for different relative values (outlined in the chart above).

Data in each category takes one of two forms, true/false or numerical. "True" counts as a positive value; "False" as zero value. Numerical values are compared with all other companies' numerical answers in order to generate a ranking. Non-reporters in these numerical cases rank worse than worst numerical respondent in any group.

Yellow and red cards

For both better and worse, the 100 Best Corporate Citizens Database is a digital representation of analog activities. Each year, based on the numbers, some companies make our lists despite some self-caused reputational damage, which usually appears as a pending or completed administrative or official legal sanction. In order to recognize these issues that might not otherwise arise through are data collection methodology, we have developed a yellow card/red card penalty system.

On our lists, a yellow card icon next to a company's listing indicates a caution—a notice of an investigation into or pending official infraction that does not yet rise to the level of expulsion, but might if the official sanction level escalates. A red card merits immediate expulsion from the list for three years.

Dell (yellow card): In July 2010, Dell agreed to pay \$100 million to settle fraud charges from the SEC, ending a case dating back to 2005. Dell did not disclose to its investors "large exclusivity payments" that Intel made to Dell in exchange for Dell's agreement not to use chips made by rival chipmaker AMD. The payments were so large that they made up 76% of Dell's operating income in the first quarter of 2007, and double-digit percentages of its earnings in several other quarters.

KBR (yellow card): KBR has a pattern of allegations and admitted breaches, including violations of laws in the US and UK and bribery among others.

Pfizer (red card): Year two of a three-year Red Card. In 2009, Pfizer was fined \$2.3 billion by the U.S. Department of Justice, after its subsidiary Pharmacia & Upjohn pleaded guilty to a felony violation of promoting off-label uses of Bextra. The complaint charged that the company sent doctors on all-expense-paid trips to resorts, gave out free massages, and paid kickbacks to doctors to get them to prescribe the drug for off-label uses.
